*Graduation Celebration FAQ Disneyland/California Adventure  
June 9-10, 2024*

**WHO CAN GO?**

- CVCHS graduating seniors.

**WHAT'S THE PLAN SO FAR?**

- Eat dinner and shower before coming to check-in on the evening of Sunday, June 9th. Our meeting time will \*likely\* be around 10:30pm or 11pm, but we'll be in touch closer to the event to confirm that once we know how many parent volunteers and police, we'll have onsite to conduct screenings, etc., to determine how quickly we can check-in all kids and chaperones.
- We will notify you on the REMIND app of our exact check-in time as we get closer to the event.
- All students will go through a security screening and be administered a breathalyzer. **If you do not pass the security screening, are in violation of the Disney dress code, or do not have your student ID you will not be allowed to board the bus and all monies will be forfeited.**
- Students must also turn in medications to be checked, collect their drawstring tote bag, and provided supplies, check in with their chaperones, find their bus, etc.
- Once students have passed the security check, they will not be permitted to go back to their cars, etc. **Once students have boarded their bus, they will not be permitted to exit the bus for any reason – so make sure you have everything you need.**
- Depart CVCHS @ at 1:00am on Sunday, June 9. Buses will NOT WAIT for anyone not on the bus on time. If you miss the bus, all monies paid for this event will be forfeited. You will not be permitted to join the event if you do not ride the bus with the group.
- Arrive @ Disneyland. You will not enter Disneyland like a regular guest, but instead enter through a Grad Nite entry point, and undergo an 'enhanced security screening' including with drug sniffing dogs on patrol.
- Your chaperone will carry any pre-approved medication through the line with you, then return it to you once inside security check.
- Next, have a great day park hopping, plus attend a grad night celebration at California Adventure. Your chaperone will have a designated meeting spot to all rejoin the group before heading to the bus.
- Depart Disneyland @ 2:00am on Monday, June 10 Arrive @CVCHS at approximately 9:00am
- **WHAT ELSE DO I NEED TO KNOW? A LOT! Please keep reading.**
- Graduation celebrations have always been promoted as a SAFE & SOBOR event. Each student will be required to go through a security check by Concord Police Officers and

trained parent & school volunteers before boarding the bus, and again before entering Disneyland by Disney Security Personnel. Student behavior will be monitored by park personnel throughout our visit. **There is a ZERO TOLERANCE POLICY for those not cooperating.**

- **On all prior Disneyland trips students caught with prohibited items were not able to board the bus or attend the trip and forfeited their monies.**
- A mandatory meeting for all attendees will be held at lunch in the gym multiple days in May to review rules and expectations. **All participants must attend one of these meetings to access bus assignments in mid-May.**

#### **WHAT CAN I TAKE WITH ME?**

- Not much, as has been the policy on all previous trips. However, you'll be provided with some items to make your trip more comfortable once you've cleared the security screening.
- In the past we've handed out small bags with bottled water, sunscreen, pre-pasted toothbrushes, feminine hygiene products, hand sanitizer, etc. You may also purchase items once you're inside the park.
- A quick rundown of approved/nonapproved items is listed [here](#). Please reach out if you have a question or preference regarding another item.
  - RX Medication—yes, with pre-approval and the attached [medical form](#) with a parent signature. Please turn in your signed medical form to the Disneyland Grad Nite box in the office no later than May 20, 2024.
  - OTC Medication—yes, with pre-approval on the attached medical form in this email and a parent signature. Please turn in your signed [medical form](#) to the Disneyland Grad Nite box in the office no later than May 20, 2024.
  - All items such as contact lens solution, OTC medication, etc. must be in a company manufactured, factory sealed, unopened container and turned in to the medical station for screening.
  - Chaperones will have standard over the counter items such as aspirin, Dramamine, Band-Aids, etc.
  - Bring your items to check- in inside a brown paper bag with your name. Any meds not preapproved with the medical form will be confiscated.
  - Wallet/billfold—yes, and **please don't forget your CVCHS student ID! You cannot enter Disneyland without it!!!**
  - Lanyard to hold student ID and credit cards--yes Phones and chargers, including headphones or ear-buds—yes; they'll be checked by security.
  - Hats—yes, if worn during security check Sunglasses/eyeglasses—yes, if shown to security at check in.
  - Sweatshirt/jacket--yes, if you have it on or in your hands for the security checks.
  - Bags, purses, fanny packs—NO. We'll have drawstring shoulder bags to hand out to all participants before we board the bus. This is the only bag allowed on the trip.

Makeup, hairspray, toothbrush, dental floss, wipes, comb/brush -NO

- Change of clothes, blankets, pillows—NO

- Cameras/go pro/video recorders—NO
- Sunscreen—NO, but it will be provided.
- Chapstick—NO, but it will be provided.

#### **HOW DO THE BUS SIGNUPS WORK?**

- Three things must happen to be cleared for bus signups:
- 1) The participant's permission slip AND waiver must be turned in by May 20, 2024, to the Disney Grad Nite box in the student services.
- 2) The participant must attend one of the mandatory meetings at lunch in May. Your attendance at this meeting must be registered by a parent volunteer—please bring your student ID.
- 3) You must sign up for our trip communication method on the Remind App.
- We'll give this info out at the mandatory meetings. An email will go out to all participants who've met these three obligations when the bus signups open in May. Anyone who signs up for a bus assignment without completing these obligations will be removed from signups until these obligations are met.
