Purchase your ticket on the Web Store or at the Fiscal Office during non-class time only. Last day to purchase a ticket is Monday, March 20th, 2023.

All students will be required to check in with their student ID. Please remember to bring it or have a picture of it on your phone.

CVCHS Students and Parents/Guardians - The Senior Brunch is a school-sponsored activity. It is our intent for this to be a fun and memorable event for your student. All participants are expected to follow all school behavior, dance and dress regulations as listed in the CVCHS Student Handbook.

Students that have any of the below issues have been placed on the **non-participation list** and will not be able to purchase a ticket at this time. If any of these apply to the student, they should meet with their counselor and/or Dean to discuss if and how they can earn the privilege to attend.

- Failing grade in a class
- Off Track for graduation (Credit Deficient)
- Attendance Rate lower than 90% (attendance rates are printed on the weekly reports)
- If student has not attended assigned Saturday School, after school or lunch detentions
- Behavior Issues

Students not eligible to purchase a ticket will be notified prior to the start of ticket sales. Students can earn the privilege to attend if improvements are made prior to 3/20/23. Students should meet with their counselor or Dean to discuss their options. If they are removed from the list, their Counselor and the Discipline Director will need to sign off before they are able to purchase a ticket in the Fiscal Office. Refunds will not be available to students who purchase tickets and are not cleared from the non-participation list.

*Failing grades are pulled from PowerSchool, if there is a discrepancy between Schoology and PowerSchool please come to the Discipline office and the error will be verified and corrected, if this is the only reason they are on the list then the student will be approved to purchase a ticket and attend.

Warning Unlawful possession, selling/supplying, or use, of any controlled substance (i.e. alcohol or drugs) will result in; suspension, including all school activities for at least 45 school days. Testing for alcohol use is done with a Breathalyzer. Any person attending a CVCHS activity must agree to be searched for non-approved substances, items or weapons. By your signature, you are acknowledging and consenting to the use of the Breathalyzer and or being searched. Anyone in possession or suspected of possession, refusing to take the test and/or violating these regulations will be removed from the event and released to their parent or parent designee. Any student in possession or suspected of using drugs will also be removed from the event and released to their parent or parent designee. The student will then be given the consequences listed above.
